Default has occurred in the payment of the Note and in the performance of the obligations of the Deed of Trust. Because of that default, , the owner and holder of the Note, has requested Trustee to sell the Property.

The Deed of Trust may encumber both real and personal property. Formal notice is hereby given of 's election to proceed against and sell both the real property and any personal property described in the Deed of Trust in accordance with 's rights and remedies under the Deed of Trust and section 9.604(a) of the Texas Business and Commerce Code.

For the avoidance of doubt, the Foreclosure Sale will not cover any part of the Property that has been released of public record from the lien and/or security interest of the Deed of Trust by . Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.
